1 FOREWORD 1

1.1 - CHECKS TO BE CARRIED OUT AT MATERIAL RECEPTION

At reception of the machine, make sure that this one is complete and in good condition in every part. If any damaged parts are found out, timely inform about that the machine Distributor, or directly contact C.I.M.A. SpA.

Upon receipt of the machine, expressly verify the following conditions:

- that the machine is delivered assembled in all its parts, and that the equipment fully complies with the requested configuration;
- that all the protections are both present and firmly fastened;
- that the oil level inside the multiplier is correct;
- that the fan, the fan protection casing or other parts of the machine ARE NOT damaged because of any bumps suffered during the transport.

The "OPERATION AND MAINTENANCE INSTRUCTIONS" manual is an integrative part of the dusters. It is identified by a Publication No. located on the frontispiece, and through which the document can be identified, traced and/or subsequently referred to.

2 GLOSSARY 2

2.1 - TERMINOLOGY

The terms FRONT, REAR, RIGHT and LEFT utilised in this publication refer to the duster as seen by an operator from behind the operative unit along the drive line and facing it: **the rear part** of the machine is that closest to the operator - and is where the distribution device (Head) is mounted - and **the front part** is the one that gets attached to the tractor.







3.3 - SAFETY NOTICES

3.3.1 - General



The personnel appointed to the use of the machine must have acquired an exhaustive knowledge of the same one and of the dispositions contained inside this publication, be able to properly interpret the symbols of the adhesives applied on the machine, and, in addition, perfectly know the safety and the work hygienic rules in force in the country where the machine itself is to be used.

All the preparation, use, maintenance, moving and transporting operations must be carried out of the regulations contained in this publication.



IT IS FORBIDDEN TO UTILISE THE DUSTER FOR PURPOSES OTHER THAN FOR ITS INTENDED USE, AS IT HAS BEEN DEVELOPED EXCLUSIVELY FOR DISTRIBUTING ANTI-MILDEW POWDERS ON AGRICULTURAL CULTIVATIONS.

Use the duster is allowed only during daylight: YOU MAY NOT USE IN NIGHTWORK. ANY USE OTHER THAN THOSE DESCRIBED IN THE USE PERMITTED IS CONSIDERED AS NOT CONFORMING AND THEREFORE IS NOT PERMITTED.



It is necessary to scrupulously abide by the following general norms:

- check that the power of the tractor is compatible with the duster to be used;
- verify that the maximum weight admitted on the three-point hoister of the tractor is compatible with the weights of the duster to be used;



On the identification plate, the full-load weight (PESO T.) of the machine is indicated, measured WITHOUT the distribution device, and WITHOUT the accessories possibly installed.

In order to calculate the weight on the hoister in operative conditions (at full load), add to the weight indicated on the identification plate (PESO T.), the weight of the distribution device which is used (see Chapter 6), the weight of the installed accessories (see Par. 4.7.2) and the 50% of the weight of the used cardan shaft (see the relevant specific manual).

- before utilisation, check the correct tightening and securing of the machine's various components, paying particular attention to the safety protections and to the moving parts;
- only utilise protected cardan shafts provided with CE conformity certification.
 Carry out the assembly only if the drive outlets of both tractor and duster are equipped with the protection counter-guard;
- check that the cardan shaft is blocked by the appropriate anti-rotation chains;
- keep people and animals away from the machine before starting it up;
- don't wear articles of clothing that might get caught in moving parts;
- keep to a low speed while negotiating bumps or crossing ditches;
- during the use of the machine, the operator must have a sufficiently good visibility on the working
 areas, consequently it is recommended to keep both clean and efficient the cab windows and the
 rear-view mirrors;
- always stop the tractor's engine and actuate the parking brake before carrying out any operation on the duster;
- never leave the machine unguarded, when the key is inserted inside the tractor control panel;



All of the maintenance and repair operations should be carried out only after having carefully cleaned all the parts of the machine.

3.3.2 - PRECAUTIONS AGAINST THE FIRES

Don't approach either flames or heat sources to the machines. The presence of plastic components, lubricants and of chemical product residuals make them potentially flammable.



- t is forbidden to make weldings if ammonium salts have been used or on parts not perfectly cleaned from any sulphur residuals.
- It is forbidden to use the machine if any free flames are present or in proximity of any incandescent material, fire residuals or glowing fires.

3.4 - SAFETY SYSTEM


All machine moving parts are suitably protected by guards and highlighted through the use of warning decals.





- It is forbidden to use the machine with these guards removed.
- Before removing the protection, stop the tractor's engine and remove the key from the control panel.
- Before beginning the distribution of the product, make sure that the lid is closed.

The pictures illustrate the machine's guarded parts:





THE OWNER AND/OR THE OPERATOR OF THE DUSTER ARE NOT PERMITTED TO MODIFY THE STRUCTURE OR THE SPECIFIC OPERATION OF THE DUSTER ITSELF. ANY REPAIRING INTERVENTION HAS TO BE CARRIED OUT EITHER AT THE DISTRIBUTORS' OR AT THE C.I.M.A. S.p.A. AUTHORIZED WORKSHOPS, OTHERWISE ANY KIND OF WARRANTY IMMEDIATELY CEASES AND C.I.M.A. S.p.A. IS CLEARED OF ANY CONSEQUENT AND/OR IMPLIED RESPONSIBILITY.

3.5 - HANDLING OF AGRO-CHEMICALS

The **operator** may be contaminated either by contact with or inhalation of the products and mixtures to be distributed.

The **environment** may be polluted by the spillage of the products, the careless conservation of empty or unwashed packages, and by pouring the products into the water system.

To avoid these risks, the filling operations should be carried out in suitably prepared and adequately equipped areas, or on the treatment site.



To use agro-chemicals (purchase, transport, loading, treatment planning, quantity preparation, field transfert, treatment performance, ending treatment waste management, equipement rinsing and waste disposal) you must follow the country rules.





Absolutely respect the rules on the label of the product used referring to the dose for hectar and to the compatibility of other products.

3.5.1 - Storage

Fixed / stationary: the site used must be well ventilated and secured by lockable doors in order to prevent even accidental access by children or unauthorised persons.

Mobile: the carrier equipment must be properly locked and kept under conditions whereby access by children or unauthorised persons can be prevented during the absence of the operator. All full or partially utilised containers must be secured against tipping, falling or breakage during transportation. Both types of storage must:

- have a suitable container for the storing of empty packaging materials should a specific storage area not be available;
- have a clean water supply readily available for washing, by means of a specific container or through connection to the waterworks system;
- have the use of fire extinguishers, should flammable products and substances be stored.



- All packages, whether whole or partially utilised, must be stored in their original packing and with the warning instructions clearly displayed and legible.
- The storage indications must always be scrupulously adhered to, as well as their utilisation and possible disposal as suggested on the product's original packaging.

3.5.2 - Specific equipment

The site at which the preparation and filling out will take place must provide for:

- all the equipment necessary to the precise measuring of both the dose of product to be mixed in the tank at every filling:
- all the equipment and means useful to the preparation of the mixture and for the cleaning of the operator in case of contamination;
- all tools necessary to facilitate the direct introduction of the agro-chemicals in the tank;
- the allocation of clothing and specific equipment in order to avoid contamination by contact or inhalation during the whole operative phase of the intervention.

3.5.3 - Disposal of empty containers and agro-chemicals residues

Agro-chemicals are classified as "special" waste and their disposal must take place separately from "urban" wastes.

Empty packaging and contaminated containers to be done away with cannot be dispersed, burned or buried.

The washing water for the tools utilised for the preparation of mixtures cannot be emptied on the ground, spilled into the sewage system or in waterways and rivers.

The disposal of special wastes is regulated by specific norms. In order to perform this operation it is necessary to obtain the relevant information from the Local Offices specifically appointed to rule on this subject. The non compliance with these regulations can cause considerable damage to persons and animals as well as polluting the environment.



3.5.4 - Personal Protective Equipment (PPE)

The use of phytosanitary products might imply a more or less high chemical risk for the workers on the basis of the toxicity and the dangerous properties of the phytosanitary product, of the level and duration of the exposure, of the absorption level through the respiratory tract, the skin, the mucosa and the ingestive tract, as well as the way and frequency of the use.

The "personal protective equipment" (PPE) are equipment that all the users of the machine need to wear and hold in order to be protected by one or more risks that are capable to treath the security or healthy during the job.

Regarding the basic requirements, PPE have to:

- be suitable to the risks that have to be prevented, without causing major risks themselves:
- be suitable to the existing conditions on the workplace;
- consider the ergonomic (easily adaptable, easy to wear and safe) or health needs for any users;
- be adaptable to the user according to his/her needs.

The PPE for the protection against dangerous chemical agents used for the operations that concern the exposition to phytosanitary products, pertains to the third class (3^{rd} class - 0000).



Use solely PPE equipped with the needed CE mark, in the scrupulous rispect of the regulations in force in the country where the machine is in use and adequate to the phytosanitary product used.

It's needed to use the PPE in each of the following working stage:

- tank filling and addition of the phytosanitary product;
- spraying,
- calibration of the sprayer.
- draining and cleaning of the tank,
- phytosanitary product replacement,
- servicina.

The following must be worn:

- for the protection of the body (gloves, suits, boots),
- for the protection of the respiratory tract, of the head and of the eyes (helmet, masks, filters, glasses, hoods and headdresses).



Filters must be replaced following the producers' instructions, and in any case:

- in case a bad smell is noticed;
- -in case a resistance to the respiratory function is noticed;
- at least once a year in case of occasional use.


For ALL PPE in use, follow the use instruction declared by the PPE producers.





4 MACHINE'S STRUCTURAL ANALYSIS 4


The pictures indicate the position of the main components of the duster.





4.1 - FRAME

The frame may be coupled to hydraulic hoists of class "1". The diameter of the gudgeon is 22mm. The pin of the third point is 19mm. in diameter.




4.2 - MULTIPLIER

- Aluminum gearbox. On the side opposite the PdP. It has a sight plug for filling and checking the oil level; at the center there is another service plug to make interventions on the conical couple easier; underneath discharge plug.
- Conical Couple with high-tensile steel helicoidal teeth, dimensioned with a wide safety margin that works in oil bath.
- PdP protection casing attached on the multiplier cover.



The multiplier should work with PdP at 540 RPM. For a good result of the treatments this condition MUST ALWAYS BE OBSERVED during the machine's operation. Utilisation is permitted with speed rates ranging between 500 and 620 RPM.





4.3 - FAN

- Aluminum carter with rear outlet.
- Centrifuge fan enclosed in steel, balanced dynamically.

4.4 - TANK BOTTOM

- It is made of aluminum and has 4 holes to let the powder fall. A distributing mixer controlled by the multiplier rotates. Underneath it, there is a register with 4 holes which allows the adjustment of the powder distribution.
- Between the lid with bush, which attaches the register to the bottom, and the pinion driving the mixer, is a felt seal against powders.
 Its functionality is guaranteed by a greaser inserted on the lid.



 Realized in polyethylene, the tank is fastened to the machine frame and provided with an overturning plastic cover.




Before opening the lid, stop the tractor and take the key out of the control panel.





Check that the lid is closed before starting the tractor again.



The control lever, which is fastened to the bayonet support through which it can be fastened on the tractor, at operator's reach, is connected to the regulation lock appendix through the actuation flexible cable.










The small square-type indicator slides on a graduated scale from 0 to 5, fixed to the duster frame. It shows the width of the opening of the distribution holes. "0" means full closure, "5" maximum delivery. The handle locks the small square that keeps the opening of the control lever in the desired position.





5 COUPLING MODALITIES

5

5.1 - HITCHING TO THE TRACTOR



Check that the tractor's "permissible carried weight" and the "rear overhang allowed" are compatible with the weight and dimensions of the fully loaded duster and complete with equipment mounted for the treatment (see Paragraphs "3.1" - "4.7" and chapter "6").



The tractor's power take-off (PTO), under all utilisation conditions, must provide a power exceeding that absorbed by the duster.

COUPLING POWER WITH TRACTORS OF AT LEAST:

18 CV = 13,2 KW for dusters ESSE 420 and ESSE 430 25 CV = 18,4 KW for dusters ESSE 520 and ESSE 530



For the models ESSE 520 and ESSE 530, the coupling to the tractor SHALL be realized by using a cardan transmission shaft equipped with a clutch.



The hitching has to be carried out on a plane surface with a suitable consistency, after having checked that all the people not charged with the operation moved away, as well as the children and the animals possibly present. The road circulation is exclusively allowed in full observation of the rules in force in the country where the machine is to be used, WITHOUT having loaded any chemical substances inside the tank.

EXECUTION:

- Loosen the chains of the lifter arms.
- 2. AStart the tractor and take the lifter's arms to the level of the machine's pins.
- 3.



Stop the tractor and remove the key from the control panel.

- 4. Insert the toggle joints on the machine's pegs, locking them with the clip pins.
- 5. Take the tension rod off of the tractor's 3rd point and locking it with the release pin.
- 6. Screw the tension rod slightly to put it in tension.
- 7. Start the tractor and hoist the duster until the 2 PTO are the same height.





Stop the tractor, remove the key from the control panel and make sure that no one approaches the hydraulic controls of the lifter.


NEVER OPERATE OR STAND BENEATH THE MACHINE OR IN THE AREA THAT COULD BE INVOLVED IN ITS SUDDEN LOWERING.

- By acting on the 3rd-point rod, vertically align the duster. N.B.: block the 3rd-point rod with the specific lock ring.
- 10. Block the coupling by tightening the chains of the hoister arms.



When the operation is completed the 2 drive outlets (PTO) must be positioned on the same axis, both in vertical and horizontal direction.






5.2 - MOUNTING OF THE TRANSMISSION SHAFT



USE CARDAN TRANSMISSION SHAFTS WITH CE CERTIFICATION.
OBSERVE THE REGULATIONS CONTAINED IN THE USE AND MAINTENANCE BOOK-LET PROVIDED BY THE SHAFT MANUFACTURER.



The cardan transmission shaft must work with the 2 COAXIAL drive outlets (PTO) or, should this not be possible, with the PARALLEL axles. In this case the angle of the joint MUST NOT EXCEED 15°.


Set the 2 drive outlets (PTO) perfectly on the same axis and measure the distance "D" between their grooves.

Length "L" of the cardan transmission shaft (refer to the picture) to be deployed, measured between the 2 stopping pawls and with cardan shaft closed, must be 40÷50mm lesser than distance "D".





The mounting, disassembling or possible other interventions on the cardan transmission shaft must be carried out with the engine switched off and with the starter key removed from the tractor's control panel.






5.3 - INSTALLATION OF CAPACITY REGULATOR CONTROL I EVER

EXECUTION:

- Mount the securing bracket on the tractor within the driver's reach and position it so that the capacity regulator control lever is fully visible and accessible during use.
- 2 Insert the control lever's bayonet support in the securing bracket.



Position the regulation lock connection flexible cable in such a way to avoid that, during the treatment, it can get torn. If necessary, use some fastening belts.



5.4 - ROAD TRAFFIC RULES



The road circulation is exclusively allowed under rigorous observance of road traffic laws in force in the country where the machine is in use.

- ALWAYS ensure that the machine overall dimension is within the limits established by the road traffic laws.
- When the overall dimension of the duster is higher than the tractor, the visible protruding load panel has to be fixed on the back of the overhang.
- It is necessary to replicate the tractor's number plate and rear lights when these are covered by the machine. The operator shall be responsible for any possible non-observance and non-compliance with the mentioned rules.



Working with dusters equipped with PNEUMATIC BOOMS WITH ARMS' HYDRAULIC FOLDING, the operator has to TOTALLY RETRACT THE SLIDING PART OF THE ARMS AND FOLD them to the closed position. BEFORE to access to the road, the operator shall check that the arms are duly locked.





7 ACCESSORIES

7.1 - PAIR OF WHEELS

The wheels thread can be adapted to that of the tractor.



MOUNT THE WHEELS <u>AFTER</u> HAVING HITCHED THE DUSTER TO THE THREE-POINT LINKAGE.

DISMANTLE THE WHEELS <u>BEFORE</u> UNHITCHING THE DUSTER FROM THE THREE-POINT LINKAGE.

EXECUTION:

1. Hitch the machine to the tractor and lift it to a height at which the wheels can be mounted.






Stop the tractor, remove the key from the control panel and ensure that no one operates the three-point lineage's hydraulic controls. AVOID OPERATING AND STANDING BENEATH THE MACHINE OR WITHIN THE AREA THAT MIGHT BE INVOLVED IN ITS SUDDEN LOWERING.

- 3. Insert the wheels' axle shafts into the machine's axle.
- 4. Adapt the wheels' track to that of the tractor.
- 5. Lock the axle shafts by means of the axle screws.
- Start the tractor and keep the duster lifted during the transfers, lowering it to carry out the treatment.



THE DUSTER MUST BE LIFTED AT EVERY DIRECTION CHANGE MAKING SURE THAT THE WHEELS ARE NOT RESTING ON THE GROUND.



7.2 - HYDRAULIC SWIVELLING DEVICE

It is an accessory used to modify the direction of the spraying during the use of the duster; it can be used only with the distribution devices with delivery on the one side.




For its use is necessary that the duster is provided with a sprayhead with VERTICAL outlet.



7.3 - CARDAN SHAFT WITH CLUTCH

It is used with safety function against overload; the relative rotation between the surfaces of the clutch limit the value of the transmitted torque.





8 FILLING 8

FILLING MUST BE CARRIED OUT WITH THE MACHINE ON A FLAT SURFACE. ON THE SITE, BEFORE THE OPERATION, THE DOSES TO BE POURED INTO THE TANK MUST BE PREDISPOSED.



IT IS NECESSARY TO ALWAYS MAKE USE OF PERSONAL PROTECTION.

EXECUTION:

- 1. Take the duster to the area in which it is to be filled and rest it on the ground.
- 2. Stop the tractor and remove the key from the control panel.
- 3. Before filling the tank, stop delivery by bringing the control lever to the "0" position.
- Before opening the lid, ALWAYS check that the tractor is STILL and that the key was REMOVED from the control board.
- 5. Open the lid of the tank.



Avoid that both BEFORE and DURING the loading any foreign objects like stones, small pieces of metal, etc., are introduced into the tank. Even if small dimensioned, such objects could, by getting into contact with the mixer during its operation, cause some sparks inside the tank and set the duster on fire.

- 6. Introduce the powder product into the tank, up to its complete filling.
- 7. Close the lid of the tank.
- 8. Start the tractor, always observing the safety norms and move to the treatment place.



Before any transferring, make sure that the powder delivery lock is CLOSED (position "0"). If the delivery lock is open and the fan is still, the powder contained inside the tank could, as a result of the vibrations, move down and compact itself inside the fan, so causing at the machine start an excessive solicitation of the moving parts, which could consequently break. As a general precaution measure, it is recommended to avoid covering great transferring distances with the loaded tank, in order to avoid the product getting compacted inside the tank.

9 CONSTANT DELIVERY CONTROL 9

The products to be used with the duster have physical characteristics that can be stongly modified by the temperature and humidity conditions at the moment of treatment. Therefore, it is not possible to obtain and set reliable delivery amounts corresponding to the various opening indexes of the delivery holes on the tank bottom.


Usually, the machine allows deliveries from a min. 0,4 up to max. 8 kg/min., with the opening index set on No. 5. To do a treatment with constant powder distribution, it is possible to set the on-of lever at the same opening position by the locking handle.



EXECUTION:

- 1. Using the on-ofl lever, find the delivery position suitable for the intervention.
- 2. Unscrew the locking lever and move it up to reach the delivery position indicator, then strongly lock it by completely screwing it back.

This operation ensures the equal opening of the delivery holes during the entire treatment.



10 OPERATING PROCEDURES

10.1 - PRELIMINARY OPERATIONS TO TREATMENT

THE OPERATOR MUST:

- Ascertain that the condition of the crops, the progress of the disease or the need for its prevention actually justify the treatment to be applied.
- Be aware of the meteorological conditions forecast for all the time necessary for carrying out the treatment.
- 3. If possible, avoid carrying out the spraying in strong wind conditions or when one detects that the sprayed product disperses away from the target crop (drifting). It is advisable to suspend the treatment when the wind speed exceeds 3 m/s (10 km/hour).
- 4. Carefully calculate the exact quantity of the product necessary for the treatment.
- 5. Check that the product is available in a quantity sufficient to complete the intervention.
- Read the product's utilisation instructions carefully, in order to ascertain the usage conditions, the correct dosage and the expiration dates.



10.2 - PREPARATORY OPERATIONS TO TREATMENT.



IT IS ALWAYS NECESSARY TO WEAR PERSONAL PROTECTION CLOTHING AND ACCESSORIES. The powdering masks do not offer any protection against toxic vapors. Avoid using clothes that can get caught in the moving elements.





Before opening the lid, ALWAYS check that the tractor is STILL and that the key was REMOVED from the control board.

- 1. Carry out all checking and maintenance operation necessary for setting up the machine.
- 2. Perform loading in a well-ventilated place. If this is done outdoors, the presence of wind increases the danger of contamination.
- 3. Avoid proximity of free flames, coals or burning objects with flammable products.
- 4. Put the emptied product packages in the appropriate container or in the storage rooms.
- Clean the equipment and the tools used for preparation and keep them in the storage area for chemical products.
- 6. Always leave the product loading and preparation area in conditions which will not cause any contamination to persons or animals, or environmental pollution.
- 7. If necessary, mark the field or the machine passage area, to provide a guide for treatment and to avoid missing spots or overlapping layers.



- AT THE END OF THE OPERATIONS NECESSARY FOR TREATMENT, THE STORAGE-CONSERVATION AREAS MUST BE LEFT IN THE CONDITION REQUESTED IN ORDER TO PERFORM THEIR PREVENTIVE AND PROTECTIVE FUNCTION.
- BEFORE RE-STARTING THE TRACTOR, CLEAR PEOPLE AND ANIMALS AWAY AND NEVER LEAVE THE MACHINE UNGUARDED DURING THE PREPARATION OPERATIONS.

10.3 - THE TREATMENT



Before any transferring, make sure that the powder delivery lock is CLOSED (position "0"). If the delivery lock is open and the fan is still, the powder contained inside the tank could, as a result of the vibrations, move down and compact itself inside the fan, so causing at the machine start an excessive solicitation of the moving parts, which could consequently break. As a general precaution measure, it is recommended to avoid covering great transferring distances with the loaded tank, in order to avoid the product getting compacted inside the tank.

IT IS ADVISABLE TO BEGIN TREATMENT AT THE HEADLANDS.

The operator must:

- 1. Start the tractor, always observing the safety norms.
- Activate the power take off (PTO) and take it to a rotation speed of at least 500 RPM. CARRY OUTTHETREATMENT



SOFTLY ENGAGE THE PTO.

The fan must reach the status of inertia and acquire a certain rotation speed before pushing the accelerator. Transmitting most of the motor power to overcome the starting take-off may cause the breakage of the multiplier gears. Pay special attention with double-clutch tractors.







The duster should work with PdP at 540 RPM. For a good result of the treatments this condition MUST ALWAYS BE OBSERVED during the machine's operation. Utilisation is permitted with speed rates ranging between 500 and 620 RPM.

- 3. Use personal protection identical to that advised for the mixture, preparation and loading, if the tractor does not have a pressurized cab with aeration filters.
- Immediately wash all elements contaminated during the teatment, promptly take off the contaminated protection clothes and discontinue the job if these cannot be replaced.
- 5. If the wind increases, follow the instructions given in the preliminary operations.
- During the pauses, stop the motor, take the key out of the control panel of the tractor and lower the hoist.
- Pay special attention when doing treatments near property lines, houses, waterways, roads or public paths.

10.4 - END OF TREATMENT - STORAGE

THE OPERATOR MUST:

10.4.1 - Daily

Keep the machine in a ventilated place, sheltered from rain or sun: sunrays are the worst enemies
of plastic and rubber parts.

10.4.2 - End of seasonal cycle

- Carry out an accurate cleaning of the duster, emptying the tank and the distribution holes of any product residue. The operation must be done without the use of water or liquid detergents.
- 2. Check to see if the machine's parts and structures are working correctly. In the case of negative results, ask for the intervention of C.I.M.A. S.p.A. dealer or authorized workshop.
- 3. Put the machine in a ventilated place, sheltered from rain, ice and rays of sun.



The machine must be stored in a secure or closed place, so as to prevent access to unauthorized personnel.

11 LIFTING AND TRANSPORT 11



THE FOLLOWING ACTIONS ARE NOT ALLOWED:

- Transporting or lifting the duster with residual quantities of product in the tank for purposes differing from its destined usage.
- The transporting of people, animals or things and/or the trailing of vehicles or equipment.
- Regarding the road circulation of the dusters equipped with pneumatic booms, see Par. 5.4.



Road transport must take place in the complete observance of road regulations in force in the Country where the machine is used.

The operator is responsible for possible defaults due to the non observance of said regulations.




11.1 - LIFTING AND TRANSPORT OF THE DUSTER



Before carrying out any operation it is essential to verify that no product residues are left in the tank.

- Check that the cables or chains used for the lifting are adequate for the weight to be lifted.
- Hook the machine through the specific support point indicated by the specific decal on the frame, checking all the parts involved in the operation.
- Lift the machine, verifying that it is properly balanced; position the duster on the transporting vehicle in perfectly stable conditions.
- During transport the machine must be immobilised and fastened to the carrier by way of suitable strapping.


ALL OPERATIONS MUST BE CARRIED OUT WITH THE ENGINE SWITCHED OFF AND WITH THE IGNITION KEY REMOVED FROM THE CONTROL PANEL.

12.1 - GREASING

At the beginning of the treatment season and after every 50 hours work, grease the felt seal with EP type NGL2 class grease.



Accurately clean the greaser before use: dirt could be introduced together with grease.





12.2 - LUBRICATION




When the machine is sitting on a flat surface, the oil level inside the multiplier should always be visible through the sight plug situated on the guard cover.

The multiplier oil has to be replaced after **1000 working hours.** A plug situated under the multiplier box allows for the discharge of the oil.

It is absolutely necessary that the oil is always kept at the required level. Any possible filling up has to be carried out through the filling cap, either by inclining or by laying down the machine: **always use oil SAE 90.**



At the beginning of the treatment season and before every intervention, check the oil level in the multiplier guard.

A. PROBLEM: Oil leakage from the cover of the multiplier box

1. CAUSE: The cover seal is defective.

REMEDY: Refer to CIMA after sale service.

2. CAUSE: The sealing ring on the cover is defective.

REMEDY: Refer to CIMA after-sale service.

B. PROBLEM: Vibration of the ventilator group

1. CAUSE: The fan is dirty or out of balance.

REMEDY: Refer to CIMA after-sale service.

2. CAUSE: The PdPs are not aligned or are not parallel.

REMEDY: Position the PdPs in the correct way.

C.PROBLEM: Abnormal and constant noise with vibrations

1. CAUSE: Breakage of the multiplier bearings.

REMEDY: Refer to CIMA after sale service.

D.PROBLEM: Non-delivery of powders

1. CAUSE: The feeding holes on the tank bottom are clogged.

REMEDY: Clean them.

2. CAUSE: Caking of the tank's contents.

REMEDY: Breake up the powder.

E.PROBLEM: Distribution on the two sides is not uniform1. CAUSE: The compensation plate of the head has moved.

REMEDY: Adjust it in order to get a uniform distribution.



ANY REPAIRING INTERVENTION HAS TO BE CARRIED OUT EITHER AT THE DEALERS' OR AT THE C.I.M.A. S.p.A. AUTHORIZED WORKSHOPS, OTHERWISE ANY KIND OF WARRANTY IMMEDIATELY CEASES AND C.I.M.A. S.p.A. IS CLEARED OF ANY CONSEQUENT AND/OR IMPLIED RESPONSIBILITY.

18.1 - General information

The goods sold are covered by a general warranty that ensures the good quality of the materials, solid construction and regular operation for twelve months from the date of delivery.

During the warranty period, C.I.M.A. S.p.A. pledges to replace, free of charge, the parts which, in his unquestionable judgement, are considered defective, provided that the flaws and defects cannot be attributed to poor use or maintenance of the product or an unreasonable, inappropriate and unsuitable use of such product with respect to the technical instructions supplied by C.I.M.A. S.p.A.

The products which have been modified, repaired, assembled or tampered with by a third party, consumption materials and the parts subject to wear and tear are excluded from the warranty.

The replacements will be made free CIMA S.p.A. works and the buyer will be responsible for all shipping and return expenses.

The buyer will be responsible for the costs of the labour needed to replace the parts considered defective. The resolution of the contract and any compensation for damage cannot be claimed by the buyer except for serious faults to be proven by said buyer.

The warranty will no longer be extended to the buyer if he does not respect the agreed upon payment procedures and terms.

18.2 - Reporting defects in goods

The claims for flaws or defects in the goods shall be submitted within eight days from when such goods are received or from when hidden defects are discovered, in writing, by means of a registered letter. No claim can be made, nor as an exception, in a court of law if the goods, for which the claim is submitted, have not been regularly paid.


